- _____ A maximum of two pets are allowed in the campground and they must be leashed at all times.

- _____ No fires allowed anywhere at Lake Martin during burn ban notices. Burn Ban information can be found on the information board near the entrance of the park.
- _____ All guests must check-in at the front office. ***The gate code is for registered guests only.***
- _____ BEWARE: Rocks and other things in the water near the boat ramp may cause cuts.
- _____ Children must be supervised at all times. No lifeguards on beach/piers – swim at your own risk.
- _____ No RVs are allowed in the cabin or mobile home areas. Parking in approved areas only. No maintenance is allowed on cars, trucks, vans, SUVs or boats.
- _____ Quiet hours 2200-0800. Please respect your neighbors.
- _____ Only charcoal allowed in grills and grills must be monitored constantly when in use.
- _____ No glass containers on the beach. What you take on the beach, you take off the beach.
- _____ The office hours are from 0900-1600, seven days a week. Except for designated Holidays.

- _____ No firearms of any kind are allowed in the park.
- _____ Fireworks are prohibited within any area of Lake Martin Recreation Area.
- _____ Playground: Children under 10 years of age must be accompanied by an adult.
- _____ Hanging clotheslines are not allowed. There are laundry facilities on site.
- _____ Check out for all units/lots is by 10:00 AM. Late checkout must be requested through the Lake Martin Office.
- _____ The DoD/DoW ID cardholder must be present upon entry of the park and will be held fully responsible for all person or persons staying within the rented location.
- _____ Due to Maxwell Gunter Lake Martin Recreation Area being a federal MWR facility, illegal drugs (to include marijuana) are prohibited. Violation of this policy may result in removal from the facility and/or law enforcement notification.
- _____ Customers are responsible for securing and safeguarding all personal belongings, equipment, and vehicles at all times. Lake Martin Recreation Area is not liable for damage resulting in theft, vandalism, weather conditions, accidents, or the actions of the third parties. All risk of loss or damage to personal property and equipment remains solely with the owner.
- _____ Cleaning procedures must be completed prior to departure. Failure to do so will result in a \$100 cleaning fee.
- _____ Lake Martin Recreation Area is a strictly smoke-free facility (including all cabins, trailers, and indoor spaces). This restriction applies to tobacco, electronic cigarettes/vapes, and marijuana. In the event of a violation: The registered guest will be assessed a \$500.00 Recovery and Remediation Fee. This fee is not a penalty, but an estimate of the
